



> "The cold water supply to the fittings shall be drawn from the same source that supplies the hot water apparatus so as to provide a balanced pressure and to obviate the risk of scalding in the event of a restriction or failure in the water supply."

A condition of this acceptance is that the fittings to be installed shall be replicas of the samples as certified by the testing agent mentioned above and without modifications. This acceptance may be withdrawn at any time if the standard of the fittings installed fails to meet that of the approved samples or if the fittings are found to be unsuitable for use in fresh water plumbing systems.
